Long Period of Disuse Made it Balk—Tested Again Today.

The test of the big transformer in the substitution of the Elmhurst, Corning and Waverly line in Corning was made Wednesday and was not a success.

The big transformer, from its long period of disuse and idleness was found to be out of working order and the test was abandoned after it was seen that the transformer would not work.

Adjustments are being made today and this afternoon another test will be made and it is expected that the transformer will be in order.

The transformer or rotary is an electrical machine to change high power current into the current suitable for supplying the trolley line with electricity.

Over 50 years ago a concrete station was built in Chemung and the machinery installed. It was never used or tested.

Electricity from Waverly was used in the test. Wednesday morning the Waverly line is complete the electricity will be supplied from Elmhurst.
